Legal Case Study

One of our clients in Dubai, UAE engaged us to address a commercial dispute with a debtor in Qatar, involving a claim amount, despite our initial attempts at amicable resolution, the debtor consistently made empty promises, eventually becoming non-cooperative and ceasing all correspondence.

We advised the client to initiate the legal procedures against him in **Qatari Courts** and sent him a legal proposal and the client approved.

We approached our partner law firm in Qatar and started the prelitigation procedures. We approached the debtor and sent him a legal notice through the notary public, the debtor became aware that we were capable of filing the case against him in front of this country's jurisdiction, and if payment was not made, we would **seize his trade license** and request the court to **seize his assets and sell it in a public auction** in addition to that we will **request the outstanding amounts along with all compensation** arising from damages incurred as a result of withholding his financial dues.

Legal Case Study

Consequently, the debtor approached us and offered to sign a settlement agreement to pay the outstanding amount in monthly installments.

The client approved and the debtor scheduled a meeting with our partner law firm and signed the agreement by which we can ensure legal enforcement in the event of any payment defaults.

What makes us extraordinary here ?

1 - As a result of our prelitigation efforts, we saved our client all the court fees and other governmental fees.

2-The client did not have to wait for the lengthy legal procedure, typically taking 6-8 months.

3 - The settlement was formalized through an agreement drafted by our professional partner law firm, providing a strong legal basis for enforcement in case of payment defaults.

4 - Our extensive network of effective partnerships worldwide sets us apart from traditional law firms.

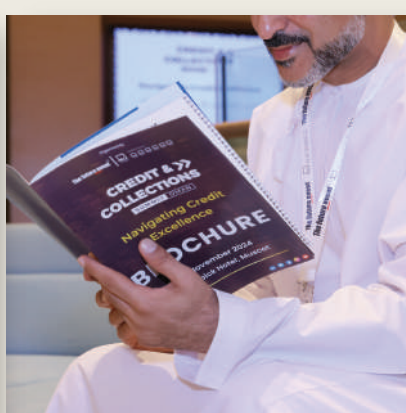
